




Introduction

The Southern African Development Community (SADC) is a Regional Economic Community comprising 16 Member States (Angola, Botswana, Comoros, Democratic Republic of Congo, Eswatini, Lesotho, Madagascar, Malawi, Mauritius, Mozambique, Namibia, Seychelles, South Africa, Tanzania, Zambia and Zimbabwe). The SADC region is endowed with diverse natural capital, within aquatic, coastal and terrestrial ecosystems of global significance for conservation of biological diversity that supports social and economic development. The regional economy continues to depend primarily on natural resources such as forestry, fisheries, and wildlife. Furthermore, about 75% of the rural communities depend directly on these natural resources for their livelihoods. In their efforts to conserver their national resources, the SADC region has developed key Protocols on Wildlife and Law Enforcement (1999), Shared Watercourses (2000), Forestry (2002), Fisheries (2006), Tourism (2009) and Environmental Management for Sustainable Development (2014), as well as Programmes and Strategies on Forestry (2009), Transfrontier Conservation Areas (TFCAs) (2013), Law Enforcement and Anti-Poaching (LEAP) (2015), Climate Change (2015) and Tourism (2019), amongst others.

The total SADC protected Protected Area (PA) estate comprises of 3940 PAs, covering approximately 1,900,000 km² in terrestrial and 475,000 km² in coastal and marine environments. Recognising that ecosystems across the globe are interrupted by political boundaries, the SADC region recognises the establishment of Transfrontier Conservation Areas as an important vehicle for SADC Member Sates to collaborate with the aim of increasing landscape connectivity and conservation success. A TFCAs is defined is defined as a component of a large ecological region that straddles the boundaries of two or more countries encompassing one or more protected areas as well as multiple resource use areas. Importantly, SADC TFCAs consist of different forms of protected areas from national reserves, game reserves, forestry reserves, communal conservation lands, among others. The SADC Regional Indicative Strategic Development Plan (RISDIP 2020 -2030) describes TFCAs as important area for regional coopertion in addressing strategic objective 6, under cross cutting Pillar 5, on




"sustainable utilization and conservation of the natural resoures and effective management of environment", through integrated cross boarder natural resources management. There are currently 18 TFCA in 16 countries in different stages of development, covering over 1,000,000 km².

APAC provides an excellent platform for SADC to raise regional and global awareness of best practice in the management of TFCAs, as well as seeking solutions to the challenges and constraints. These include the need for financing mechanisms such as the SADC TFCA Facility to become sustainable, requiring further resource mobilisation linked to other similar mechanisms, as well as a number of policy bottlenecks that constrain the ability of SADC to unlock the full potential of its wildlife economies. The objectives of the SADC pavilion are therefore to:

- Showcase SADC TFCA implementation across the region as a great chain for regional integration and development through its connected ecosystems;
- Catalysing partnerships and attracting donors to promote sustainable financing for SADC TFCAs;
- Seeking solutions for challenges of managing Protected Areas in current context (e.g community livelihoods and wildlife economies).

Novel approaches to address drivers of wildlife trafficking in Great Limpopo, Kavango-Zambezi (KAZA) & Malawi-Zambia TFCA (USAID, WWF, IFAW)

Session brief: The USAID Combatting Wildlife Crime Program has supported landscape grants to address wildlife trafficking impacts on wildlife and people in three TFCAs – Kavango Zambezi Transfrontier Conservation Area (KAZA TFCA), Greater Limpopo Transfrontier Conservation Area (GLTFCA) and Malawi-Zambia Transfrontier Conservation Area (MAZA TFCA) supported by VukaNow. Demonstrating the Value of SADC TFCAs & Understanding the Funding Modalities for Investment (SADC, GIZ)

Session brief: SADC's eighteen TFCAs, represent a unique, non-substitutable ecological asset spanning approximately 1,000,000 km2 and covering terrestrial, coastal and marine environments. Despite the potential role of TFCAs in sustainable, economic, and social development in SADC, it has been difficult to quantify and communicate the tangible benefits generated by these areas to beneficiaries at local, regional, and global scales. Using case studies, the authors show the value of TFCAs to beneficiaries as well as the non-substitutable nature of these ecological assets. Experiences & lessons on community fisheries in the Namibian component of KAZA TFCAs (Namibia Nature Foundation)

Session brief: Co-managed Fisheries Reserves are waterbodies for which use restrictions are defined and enforced by local communities and which are officially recognized by the Namibian Government. It is a community-centric, ecosystem-based adaptation approach that improves the socio-ecological resilience of riverine communities while generating sound conservation outcomes. The session will demonstrate the success of this program and present our knowledge products, which includes guidelines, a milestone-based toolbox for operations and a virtual training for systematic and replicable learning. The products help streamline implementation and build capacity among other agencies who wish to contribute to building a network of reserves across national boundaries.

NNF with its partners will soft-launch the new Standard Operating Procedures for Community Co-managed Fisheries Reserves in Namibia, together with the Tackle Box, a step-by step instruction for practitioners supporting the establishment of fish sanctuaries.

Developing new approaches to enhance the wildlife economy of the Greater Kruger Area in South Africa (Conservation Outcomes)

Session brief: It is essential to develop new models of community involvement which enable meaningful economic benefits to communities, based on a growing and sustainable rural economy, and proper joint responsibility in protected area management. An underutilised potential income stream in South Africa includes game meat production. But if it is to be an effective means of deriving income, it must be ethically undertaken and under-pinned by best management practices such as effective, transparent and justifiable wildlife management systems. Such an approach is being explored in the Greater Kruger Area, incorporating the Kruger National Park and the private, communal and provincial protected areas that make up the open system of the Greater Kruger Area.

Conservation clinic: Critical management & leadership success factors for tourism concessions (IUCN TAPAS, GIZ)

Session brief: There are many success stories of tourism concessions in the SADC region. There are also many that do not successfully conclude the concession engagement process, and many that find the post contract award management difficult. With the view that various guidelines are available, the discussion will focus on the management and leadership aspects of tourism concession management. Discussion points will include robust short-, medium- and long-term policy & strategy benefits, the mandates and positioning of public-private-partnership (PPP) leaders in organizations and relating to 'doing it right first time', personality profiles of PPP leaders and how tourism skills/knowledge attributes balance with that of concession transactions. A discussion on where the management of concessions i.e., contract engagement and contract management will follow to allow for critical thinking amongst delegates.

Session brief: TFCAs in Southern Africa have been identified as key anchors for the growth of regional tourism, based on the high levels of interest in Nature, Culture and Community based tourism in the SADC region. The sessions will focus on cross-border nature-based tourism market development in the SADC TFCAs presented by SADC, Boundless Southern Africa, GIZ and partners from TFCA member states. Session brief: This session will provide background to the development of the Local Communities: First Line of Defence against Illegal Wildlife Trade (FLoD) methodology. We will explain how the methodology works and how it has produced unique lessons and insights into the importance of articulating and testing theories of change and their underpinning assumptions when designing and implementing community-based conservation initiatives. We will trace the evolution of the methodology and will introduce new training materials and future plans for supporting the use of this methodology in the SADC Region.

Panel Discussion: Introduce Transboundary Water Governance in Trans-boundary Natural Resource Management for Africa (USAID Resilient Waters Program, GIZ)

Session brief: The session will explore the role TBNRM can play in promoting a change in the paradigm for transboundary conservation that is more centred on ecosystems, its goods and services, by exploring the benefits provided by using water as a key driver of transboundary conservation, specifically for water scarce areas with erratic and/or abused ground and surface water sources. The panel discussion will focus on the following:

- 1. How should TFCA's and Transboundary River Basin Organisations with overlapping land use and livelihoods improvements objectives coordinate their work?
- 2. Are MOUs between TFCA's and River Basin Organizations an effective instrument to ensure co-operation?
